At the outset, the Chairman informed the house that the UGC, vide its notification bearing F.No. 22-1/2014(AC) dated 19.06.2014, granted autonomous status to Heritage Institute of Technology and had instructed WBUT to issue necessary orders in this regard. Agenda No.5: Miscellaneous

- (i) As the process of admitting students for the current academic session 2014-2015 would commence immediately, the house unanimously resolved to adopt the WBUT admission norms, rules and regulations for the Academic Session 2014-2015 in HIT as an autonomous institute.
- (ii) It was further resolved that the policy for admission for next academic session 2015-2016 should be worked out by the Academic Council and forwarded to the BOG for its approval. As such, the Departmental Boards of Studies should start framing the admission norms, rules and regulations and put it up for approval of the

Academic Council at the earliest. This admission policy should also spell out reservation policy and other specific admission criteria, if any, amongst others.

- (iii) The Academic Council requested the Dean (Student Affairs) to frame regulations for Sports, Extra Curricular activities and proper maintenance and functioning of the playgrounds and hostels and put it up before the Council for consideration.
- (iv) The Academic Council advised that regulations regarding institution of scholarship / studentship / fellowships / prizes and medals should be framed and placed before the Academic Council for recommendation to the Board of Governors for its institution.
- (v) The Executive Director brought out that the Trustees wished to include values and ethics as a regular course in the curriculum. The issue was discussed at length. The Principal suggested that since 20% students are admitted through Lateral Entry in the 2nd year, such course should be introduced from 2nd year onwards. It was also decided that the course content should be carefully designed and there is should be more of application of ethics and values in the engineering profession. In this context, Prof. M.K. Mitra suggested that the professional ethics should be used for conflict resolution.

It was finally decided that the course would be introduced from 2nd year with 1 (one) credit point per year from the academic session 2015-2016. While the 2nd year curriculum should be more of theoretical in nature, it should be more of project and colloquium oriented in the final and pre-final years. The Boards of Studies should be instructed to frame the curriculum accordingly. For the academic year 2014-2015, it was decided to introduce values and ethics as an audit course as a Pilot Project.

(vi) It was decided that the next meeting of the Academic Council will be held on 25.07.2014 at 11:00 a.m.

There being no other item, the meeting ended with a vote of thanks to the Chair.

Powers and Functions of the Academic Council

The Academic Council has powers to:

- (i) scrutinise and approve the proposals of the Board of Studies with regard to courses of study, academic regulations, curricula, syllabi and modifications thereof, instructional and evaluation arrangements, methods, procedures relevant thereto etc., provided that where the Academic Council differs on any proposal, it will have the right to return the matter for reconsideration to the Boards of Studies or reject it, after giving reasons to do so
- (ii) make regulations regarding the admission of students to different programmes of study in the Institute
- (iii) make regulations for sports, extra-curricular activities, and proper maintenance and functioning of the playgrounds and hostels
- (iv) make proposals to the Board of Governors for establishment of a new department / centre for study and research
- (v) recommend to the Board of Governors proposals for institution of new programmes of study
- (vi) recommend to the Board of Governors institution of scholarships, studentships, fellowships, prizes and medals, and to frame regulations for the award of the same
- (vii) submit each year its Annual Report to the Board of Governors
- (viii) perform such other functions as may be assigned by the Board of Governors.

Meeting and quorum

- (i) The Academic Council should meet at least four times a year
- (ii) 3/5th of the members including any two of the Chairman, Dean (UG) and Dean (PG & Research) shall form the quorum for a meeting
- (iii) In absence of the Chairman, Dean (UG) shall preside over the meeting.
